Duties and Responsibilities	
<p><b>Gym</b></p> <ul style="list-style-type: none"><li>• Supervise activities in the Fitness Room and operate the equipment in a manner consistent with safe working practice, ensuring the efficient and effective operation of the facility</li><li>• Undertake all day to day cleaning and maintenance of the equipment and fittings, to the highest possible standards, bringing to the attention of the Centre Management any faults or major repairs</li><li>• Deliver group exercise activities, as required</li><li>• Maintain own mandatory qualifications, licensing and CPD/ training requirements.</li></ul> <p><b>Recreation Assistant</b></p> <ul style="list-style-type: none"><li>• Assist in the communication and promotion of the centre's services.</li><li>• Establish and maintain excellent relationships with our customers and potential customers, handling and escalating complaints where appropriate.</li><li>• Adhere to the Equality and Diversity Policy, Health and Safety procedures, operating procedures, customer service standards and uniform policy at all times</li></ul>	



- Carry out health and safety checks as directed by Centre management, passing results immediately to the appropriate person and escalating potential issues promptly
- Assist with daily operations ensuring effective, accurate and timely set-ups and take-downs and changeovers

#### Reception

- Undertake cash reconciliation and banking duties in accordance with financial policy and procedures
- Monitor and control entry to the Centre
- Ensure all customer sales and bookings are managed correctly, assisting customers in their choices

#### Senior Sports Coordinator

- Assume responsibility for centre operations on a shift rota basis, ensuring the efficient and effective operation of the facility, including key holding, opening / closing the centre and managing individuals.
- To carry out any other duties associated with the work of the centre as may be determined by the Sports Centre Manager.
- To see that day to day maintenance is carried out in accordance with operational procedures.
- To regularly inspect the premises and report promptly the need for repairs to buildings, furnishings, fittings, plant and equipment to the Site Manager and Sports Centre Manager.
- To be responsible for areas of COSHH including safe storage of chemicals and cleaning equipment.
- To be responsible for the cleanliness of all facilities in conjunction with cleaning rota
- To undertake a first aid qualification (paid for by the Trust) and manage first aid incidents across the centre as they arise, including keeping an up to date record of accident and incident report forms.

#### Generic Duties relevant to all members of Staff

##### Working with colleagues and other relevant professionals

- Communicate effectively with other staff members, customer and service users
- Collaborate and work with colleagues and other relevant professionals within and beyond the Trust
- Develop effective professional relationships with colleagues

##### Professional development

- Help keep their own knowledge and understanding relevant and up-to-date by reflecting on their own practice, liaising with their line manager and identifying relevant professional development to improve personal effectiveness
- Take opportunities to build the appropriate skills, qualifications, and/or experience needed for the role, with support from the Trust
- Take part in the Trusts appraisal and performance management procedures



### Personal and professional conduct

- Uphold public trust in the education profession and maintain high standards of ethics and behaviour, within and outside school
- Have proper and professional regard for the ethos, policies and practices of the Trust, and maintain high standards of attendance and punctuality
- Demonstrate positive attitudes, values and behaviours to develop and sustain effective relationships with the Trust community
- Respect individual differences and cultural diversity

### The Trust

### ICT

- It is expected that all teaching and support staff follow the ICT Vision of the Trust.
- All staff will be expected to utilise ICT and to improve communication and reduce paper use. Security procedures must be followed when using ICT systems.

The duties and responsibilities in this job description are not restrictive and the post-holder may be required to undertake any other duties that may be required from time to time. Any such duties should not however substantially change the general character of the post.
